

(Point to Point Handlers Permit Application Enquiries 045 445617)

Dear Sir/Madam,

Enclosed are details and an application form for a Point to Point Handlers Permit.

The Horseracing Ireland Act 2016 dictates that all registration charges in relation to point to points, including handlers permits and the registration of hunters certificates will be collected by Horseracing Ireland (HRI) and then returned to the IHRB. Handlers permits, hunters certificates, passports accompanying hunters certificates and any related documents for such registration purposes, will still continue to be sent to the Offices of the IHRB and processed as normal. However, payments to register these documents, must be processed by HRI.

Considering these changes, it will be necessary for you to open a HRI account (if you do not already have one) before your Point to Point Handlers application form is lodged at the Offices of the IHRB. Please contact any member of the client accounts team in HRI on 045-455444 should you have any queries in this regard. Once opened, you must ensure that there are always sufficient funds in your HRI account to cover the cost of any charges as otherwise your Handlers Permit and/or hunters certificates will not be registered.

The enclosed Point to Point Handlers Permit application form and any related documents should be completed in full and sent to the **Offices of the IHRB, The Curragh, Co. Kildare, R56 Y668**. Any payments received to the IHRB, in any format, cannot be processed and will be returned, this will result in a delay in the registration of your Point to Point Handlers Permit and/or hunters certificates.

Can you please include your Post/Eircode in the space provided on the attached application form to facilitate the return of passports for horses during the Point to Point Season. It will also be necessary for you to include an email address on your application form as you will be contacted by email with any queries regarding your horse's flu vaccinations at a point to point meeting.

Due to the General Data Protection Regulation (GDPR), if you wish to have your details published by Industry Organisations you must give your consent to do so by ticking the box in the relevant Data Protection section on the attached Point to Point Handlers Permit renewal form.

Please allow up to seven working days for the attached application form to be processed from the time it is received at the Offices of the IHRB.
