Thank You for your enquiry.

Enclosed are details and an application form for a Point to Point Handler's Permit.

The Horseracing Ireland Act 2016 dictates that all registration charges in relation to point to points, including handler's permits and the registration of hunter's certificates will be collected by Horseracing Ireland (HRI) and then returned to the IHRB. Handler's permits, hunter's certificates, passports accompanying hunter's certificates and any related documents for such registration purposes, will still continue to be sent to the Offices of the IHRB and processed as normal. However, payments to register these documents, must be processed by HRI.

In light of these changes, it will be necessary for you to open a HRI account if you do not already have one before your Point to Point Handler's application form is lodged at the Offices of the IHRB. Please contact any member of the client accounts team in HRI on 045-455444 should you have any queries in this regard.

Once opened, you must ensure that there are sufficient funds in your HRI account at all times to cover the cost of any charges as otherwise your Handler's Permit and/or Hunter's Certificates will not be registered.

The enclosed Point to Point Handler's application form and any related documents should be completed in full and sent to the **Offices of the IHRB, The Curragh, Co. Kildare, R56 Y668**. Any payments received to the IHRB, in any format, cannot be processed and will be returned, this will result in a delay in the registration of your Point to Point Handler's Permit.

Can you please include your Post/Eircode in the space provided on the attached application form to facilitate the return of passports for horses during the Point to Point Season.
